Methods and tools for IPM (1)

Organizing of training for farmers according to the programs certified by the Ministry of Agriculture (LT,LV)

- ➤ Who sells, stores, buys, uses pesticides
- Information materials on the harmful organisms
- Programs for crop cultivation in organic and
 - conventional farm
- ➤ Open days on farms for farmers





Methods and tools for IPM (2)

Establishing of Demonstration Field Trials (LT,LV)

PURPOSE – move research to the farmers' fields

Partnership: researcher, adviser, farmer











Methods and tools for IPM (3)

Goals of establishment of demonstration farms (LV)

- To promote links between research and agricultural production
- To promote use of results obtained within theoretical studies by informing a wider range of producers
- ➤ To promote implementation of innovative solutions and agricultural development





Methods and tools for IPM (4)

Provision of individual advices and services related with IPM (LT,LV)

- Advice on plant cultivation.
- Advice on the harmful organisms and plant protection.
- Service to prepare report on used plant protection products.
- Service to prepare report on Field history (LV)

Economical and legislation aspects

Independent and neutral opinion!



Methods and tools for IPM (5)

Diseases and pests forecast:

- For horticulture (in LT done by researches, in LV done by association and researchers)
- For grain, oil rape seed, potatoes (in LT, LAAS since 2011, in LV advisers, plant protection service, researchers)







Diseases and pests forecast

- Objective timely identification of disease and pest spreading and timely use of chemical protection means.
- Monitoring of plant disease and pest spreading in field
- Assessment of potential damage to yields by pests, provision of independent consultations
- Graphic dynamics and visual materials of harmful organism spreading – in <u>www.agroakademija.lt</u> and <u>www.llkc.lv</u>





Use of Meteorological Data for Disease and Pest Forecast

- ➤ Temperature, precipitation, wind direction and speed have great influence on disease and pest spreading.
- Metpole establishes the mentioned parameters for a specific territory and relate them with disease forecasting modules





Future prospects

- Continuation of present activities
- Improved forecast (LT)
- ➤ GIS maps and data from Plots register (LT)propose services for precise farming
- > Trainings for farm employers (LV)
- ➤ Trainings for organic and conventional farmers about IPM
- > Trainings for advisers
